- 2. The duration of your talk time is: 30 minutes
- 3. You should set at least 5 minutes time for QA
- 4. Please submit your PowerPoint/outline one month before the event, as they must reviewed by the UW Quality Control Officer and Planning Committee.
- 5. Make sure to discuss your 3 questions you had submitted during your talk.

- b. Your will refrain from making recommendations, regarding products or services, unless all relevant products or services applicable to the same procedure or treatment are presented in an unbiased manner.
- c. If you decide to add more slides later if you will need to resubmit the presentation for review by UW.

- b. If you decide to change your questions , answers or feeder responses you will need to let us know by September $1^{\rm st}$ 2020, as we conduct a pre and post conference questionnaire and will have to update them in our survey
